## **ANSI Energy Efficiency Standardization Coordination Collaborative Seeks Input on Relevant Standards and Existing Gaps in the Built Environment**

As part of its ongoing efforts to assess the energy efficiency standardization landscape and carry out the development of a standardization roadmap for **energy efficiency within the built environment**, the [American National Standards Institute \(ANSI\) Energy Efficiency Standardization Coordination Collaborative \(EESCC\)](#) is soliciting input regarding relevant standards, codes, guidelines, and conformance programs that are available or under development, and what perceived gaps in energy efficiency standardization and conformance activities currently exist. The EESCC is reaching out to current EESCC members and organizations in the ANSI federation, as well as other individuals and groups in the larger standards and conformance community and beyond.

The EESCC has set up online forms to make it easy for stakeholders to submit information about relevant standardization documents (standards, codes, guidelines, and regulations), conformance programs, and standardization gaps. Submissions should consider the following questions:

- What standardization documents or conformance programs related to the built environment currently exist and what are on the horizon?
- What is the goal of the document or conformance program in question?
- Who is the standardization document or conformance program intended to serve, and how is it being used in the market?
- Is the document or conformance program being implemented at the state or federal level?
- What building types does the document or conformance program apply to?

Submissions regarding major gaps, challenges, or untapped opportunities in the energy standardization landscape are also encouraged. Submitters are asked to explain why the gap is a priority, who the affected stakeholders are, and how the gap could be addressed by the public or private sector.

The EESCC will hold its inaugural plenary meeting on **January 22-23, 2013**, at the Sheraton Pentagon City Hotel in Arlington, Virginia. Participation in the January plenary is free of charge. **Register [here for the plenary](#)**. A block of rooms at the Sheraton is available for Monday, January 21, and Tuesday, January 22, 2013 at a discounted rate of **\$209 per night, plus tax**. The EESCC has also begun holding regular web meetings of its five Working Groups (WGs), which were created under the leadership of co-chairs from the public and private sectors to oversee areas of particular focus:

- WG 1: Building energy and water assessment standards
- WG 2: Systems integration and communications

- WG 3: Building energy modeling, rating, and labeling
- WG 4: Evaluation, measurement, and verification
- WG 5: Workforce credentialing

The ANSI [Energy Efficiency Standardization Coordination Collaborative](#) (EESCC) is a cross-sector, neutral forum and focal point for broad-based coordination among energy efficiency activities involving or impacted by standardization (i.e., standards, codes, conformance activities) and regulations. The objective of the collaborative is to assess the standardization landscape, and carry out the development of a standardization roadmap for energy efficiency within the built environment.

The EESCC is led by two highly-esteemed co-chairs from the public and private sectors: **Benjamin Goldstein**, energy efficiency workforce development and standards coordinator in the U.S. Department of Energy's Office of Energy Efficiency and Renewable Energy, and **John Tuccillo**, vice president of global industry and government alliances at Schneider Electric, and president and chairman of the board of The Green Grid.

## **UNECE, FAO and partners announce plans for European Forest Week 2013**

Forests, their products and services

The European Forest Week (9-13 December 2013) will be celebrated with events in Rovaniemi Finland at Metsä2013 (joint meeting of the UNECE Timber Committee and the FAO European Forestry Commission), and throughout Europe via a variety of events.

The week will highlight the contribution of forests and forest products to a green economy. It will provide a unique communication and outreach opportunity to raise the visibility of the forest sector and the multiple services wood contributes to our daily lives. The European Forest Week will provide an umbrella for forest related celebrations organized by different public and private organizations throughout Europe.

Many events will be held on-site, at the Metsä2013 venue in Northern Finland, while other activities will take place throughout Europe with countries' contributions at national and local levels. Celebrations outside of Metsä 2013 may include:

- \* Celebrations of forests at the national and local levels;
- \* Specific events by private or public organisations;
- \* Competitions, exhibits, fairs, school activities;
- \* Videos and Publications

The organizers encourage wide participation of government officials from forestry and non-forest sectors as well as representatives of international, regional and subregional organizations that deal with forest-related issues in the region, including NGOs, the private sector, schools and academic institutions.

Registrations for on-site and in-country activities will be opened soon.

### SWST Visiting Scientist Program

The Society of Wood Science and Technology invites you to participate in the SWST Visiting Scientist Program as a "host Institution". Please fill out a "[Request to Participate Form](#)" (PDF) and send it to the Executive Office. A list of available visiting scientists is available at:

The procedure to participate as a host institution is as follows:

1. Fill out the request to participate form and return to the address on the bottom of the form. In selecting a Visiting Scientist, please consider the cost associated with cross-country travel since the Program has a limited budget. Note that the form has a convenient entry in which you can offer to contribute the the Visiting Scientist Program to permit us to cover more visits.
2. The request will be reviewed by the Visiting Scientist Program Committee, who will contact both the institution and the Visiting Scientist. This is a very important step, since we are many times able to coordinate multiple visits by the same Scientist.
3. Once the visit has been approved, the institution and scientist will be asked to arrange the details of the visit (dates, subject, etc).

4. The host institutions are to provide lodging, meals, and local transportation for the Visiting Scientist. The normal visit is one to two days. The host institution will also be expected to arrange for appropriate "PR" to maximize the value of the visit.
5. Following the visit, the requesting member at the host institution will be asked to provide a report on the visit. This will be published in the bimonthly SWST Newsletter. The Visiting Scientist Program will reimburse the scientist for travel expenses.

The SWST Visiting Scientist list includes only SWST members in good standing. If you are interested in a visit by someone not listed, please be sure to note that on the request form. Since the Program is supported through SWST member dues, the policy is to approve visits by SWST members only. If you have any special programs or questions, please do not hesitate to contact us.
